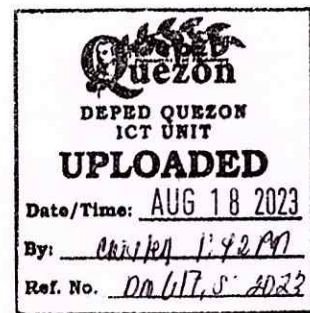

In accordance with the **DepEd Order No. 31, s. 2022** entitled "Child Rights Policy: Adopting the Rights-Based Education Framework in the Philippine Basic Education" and Guidelines on Express System of Reporting and Intervention of Child Abuse, Discrimination Against Children in School, Corporal Punishment and Any Analogous or Similar Incidents and Bullying Incidents in DepEd CALABARZON or the **Regional Memorandum 217**, the Division of Quezon, through the Youth Formation Section, will conduct an Online Convergence on Strengthening Child Rights in Education.
