- 1. Pursuant to DepEd Order No. 28, s. 2018 titled Policy and Guidelines on Oplan Kalusugan (OK) sa DepEd and DepEd Memorandum No. 50, s, 2025 titled Learners' Health Assessment and Screening for School Year 2025-2026, this Office announces the conduct of the OK sa DepEd One Health Week on July 7-11, 2025 in DepEd Offices, district and learning centers.
- 2. The activity shall highlight health activities featuring, but not limited to, the six major DepEd flagship programs to emphasize the health and nutrition services in achieving the learners' full educational potential and supporting the personnel's productivity.
- 3. The following activities are suggested during the week-long celebration:
 - a. School level orientation of parents, communities, partners and other stakeholders on different school health and nutrition programs including important policies and guidelines;
 - b. Conduct of school health service activities such as medical and dental examination and treatment, referral, deworming, vision and auditory screening, height and weight taking and nutritional assessment;
 - c. Conduct of other school-based and age appropriate services such as immunization, counselling and other screening services in collaboration with partners;

- d. Launching of age-appropriate health and hygiene practices such as individual and group handwashing and toothbrushing activities, food hygiene, personal hygiene, and mentrual hygiene management;
- e. Rapid classroom inspection, conduct of daily cleaning and the needed repair and maintenance;
- f. Kick-off activity of the School Based Feeding Program and Gulayan sa Paaralan;
- q. Exhibits/forums on the National Drug Education Program, Adolescent Reproductive Health Education, Mental Health and Tobacco Control; and
- h. Open house of canteens featuring healthy food and beverage choices.
- 4. The health services and interventions started during the One Health Week shall be continued by the schools within the school year in coordination with the SDO Health Personnel and their partners.
- 5. Please see attached Enclosure for the schedule of activities and templates for the submission of accomplishment report for reference.
- 6. Submission of consolidated district accomplishment report properly signed shall be on or before August 4, 2025 at the School Health Section, Talipan Pagbilao Quezon.
