



- Certified True Copy of Title, Mother Title, Original Certificate of Title or Transfer Certificate of Title named to the heirs, in case of death of original donor or landowner
- iii. Special Power of Attorney from Central Office
- iv. Most recent Tax Declaration
- v. Approved Lot Survey Plan, if any
- vi. School Site Development Plan, if any
- vii. Certificate of Tax Payment/Certificate of Non-Tax Delinquency
- b. For schools with signed and notarized Deed of Donation/Sale and in the process of facilitating the transfer of land title to the school through the Register of Deeds:
 - Blue copy or Second Copy of Original Certificate of Title (OCT) and Transfer Certificate of Title (TCT) as part of the documentary requirements in applying for the release of Certificate Authorizing Registration (CAR) from the BIR;
 - BIR Form No. 2313-R or Certificate Authorizing Registration (CAR) for Transaction Involving Transfer of Real Properties stating the details of payment of capital gains tax or donor's tax
 - iii. Real Property Tax Clearance
 - iv. Transfer Tax Receipt or Proof of Payment
 - v. In case of agricultural land, DAR Clearance
- c. For reimbursement of expenses for Taxes, Duties, and Licenses (UACS Code 50215010) and Survey Expenses (UACS Code 5020701000), the following shall be submitted to the Accounting Section:
 - 3 copies of Disbursement Vouchers (With Landbank Account No. of Service Provider
 - Billing Statements (With Abstract Scope of Work and Amount of Payment signed by the surveying company), if applicable
 - iii. Official Receipt
 - iv. Pictures of Service being rendered, if applicable
 - v. Service Provider's BIR Certificate of Registration, DTI, Mayor's Permit, if applicable


