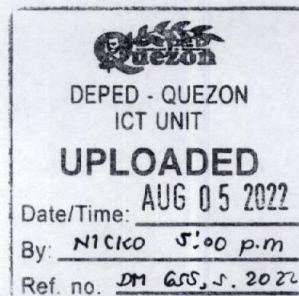

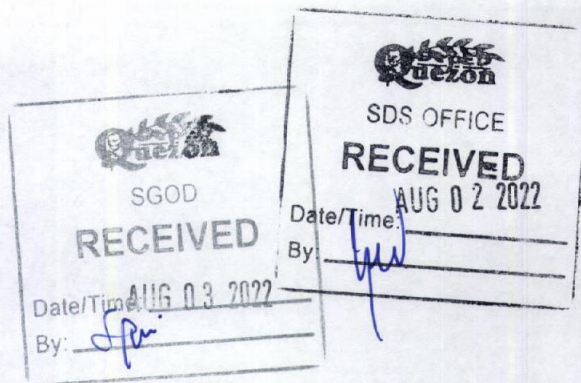

Greetings of peace and prayers of good health be with you!


Based on the Department of Health (DOH) - National Vaccination Operations Center (NVOC) Advisory No. 1, all National Government Agencies (NGAs) are requested to submit reports on the COVID-19 vaccination status of their employees. This is in line with the Presidential Directives for the First 100 Days of the COVID-19 Vaccination Program. The masterlist will be used in the identification of target offices and establishments in scaling up our vaccination activities. From July 26, 2022 to October 8, 2022, the province shall aim to attain the following targets based on the directive: *(1) increase to 50% coverage of the 1st booster dose of all eligible population, and (2) increase to 90% coverage of the primary COVID-19 vaccine series for the senior citizen population.* Attached is a copy of the presidential directives on COVID-19 response and vaccination program and the DOH Advisory No. 1 for your reference.

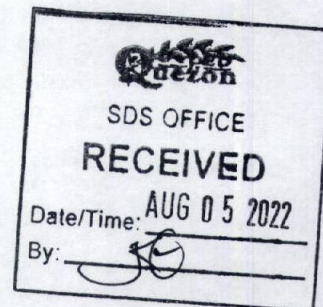

**SUBJECT: Presidential Directives on COVID-19 Response and Vaccination
Program**

Please find attached (<https://bit.ly/DOHOPPresentation>) presentation on COVID-19 updates that was made to President Ferdinand R. Marcos, Jr. and his team today, 6 July 2022. The recommendations herein have been **duly approved by the President**.

In line with this, the National Vaccination Operations Center (NVOC) is tasked to ensure that all relevant DOH units and stakeholders work together to reach **90% coverage for primary series of the A2 population (senior citizens) and 50% coverage for first booster of the general population on or before the President's first 100 days - or 8 October 2022**. This shall be the main conditionality to safely remove mask mandates, limit the use of Alert Levels System as an internal planning/activation tool, and fully open schools and remove other travel restrictions.

To ensure that the above-mentioned target will be achieved within the prescribed timeline, please see Annex A for more detailed instructions.

Advisory No. 1
Guidance on the Reporting of COVID-19 Vaccination Coverage
from National Government Agencies

This advisory is being issued to provide guidance pertaining to the Presidential Directives for the First 100 Days of the COVID-19 Vaccination Program. From *26 July 2022 to 08 October 2022*, the country shall aim to attain the following targets (1) increase the coverage of the 1st booster dose of all eligible population to 50% and (2) increase the coverage of the primary series of Senior Citizens to 90%.

In line with this, the Department of Health (DOH) would like to request **all National Government Agencies (NGAs) to submit reports on the COVID-19 vaccination status of their employees** to c19vaccineopcen@doh.gov.ph using the standard format indicated in *Annex B*. The DOH shall consolidate these prior to submission to the Office of the President through the Office of the Executive Secretary.

Mother Agencies are expected to consolidate the report from their respective regional counterparts and attached agencies and submit to DOH on the following dates:

1st Reporting:	22 July 2022 (Baseline Data)
2nd Reporting:	15 August 2022
3rd Reporting:	15 September 2022
Final Reporting:	8 October 2022 (Endline Data)

The DOH clarifies that this report is *different* from the data reporting in the VAS line list in vaccination sites that is submitted to the Local Government Units (LGUs).

Additionally, all agencies are requested to review/update their COVID-19 vaccination plans based on the current coverage and assess their capacity to implement COVID-19 vaccination in their offices. The DOH, through its Centers for Health Development in coordination with the concerned Local Government Unit, will provide the necessary assistance (manpower, vaccines, etc.).
