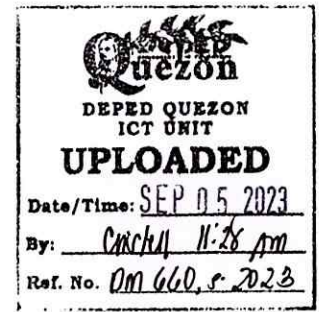





Administration of the 2023 Special Philippine Educational Placement Test (PEPT)

1. Pursuant to DepEd Memorandum No. 49, s. 2023, this Bureau announces the extension of the test registration in select schools division offices (SDOs) for Special PEPT from August 31, 2023 to **September 15, 2023**.
