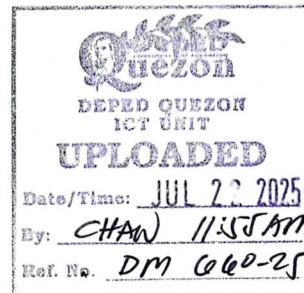

**REITERATION OF DEPED MEMORANDUM NO. 244, S. 2025 ON THE SUBMISSION OF ASSESSED VALUE OF EXISTING GABALDON BUILDINGS**
