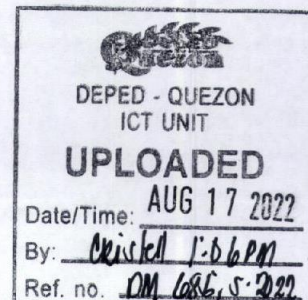

1. In reference to the **Dangerous Drugs Board Regulation No. 5, s. 2007** titled **Institutionalizing the Barkada Kontra Droga (BKD) Program**, this Office, the School Governance and Operations Division – Youth Formation Section strengthens its implementation beginning school year 2022-2023 by widening its coverage in the elementary level and supporting and collaborating with the **National Drug Education Program (NDEP)**.
2. All central elementary schools are hereby advised of their establishment as the center of development for the BKD program in their level.
3. Schools listed in Enclosure 1 shall designate a BKD Junior Advocates teacher-adviser who shall facilitate the conduct of membership campaign for Grades 4 to 6 from **August 22, 2022 to September 2, 2022**.
