

AVAILABILITY OF SDO QUEZON'S BREASTFEEDING STATION

- DepEd Quezon through the Division GAD Focal Point System and School Health Section (SHS)
 announces the availability of Breastfeeding Station in the SDO Talipan Pagbilao, Quezon.
- 2. Said station is located between the SHS Office and the COA Office, near the Records Section.
- Nursing employees are entitled to break intervals in additional to the regular time-off for meals to breastfeed or express milk.
- 4. Nursing employees shall notify their immediate section head before leaving their work station. These intervals which include the time it takes an employee to get to and from the workplace lactation station shall be counted as compensable hours worked. Usually, there could be 2-3 breastmilk expressions lasting to 15-30 minutes each within a workday.
- 5. The Breastfeeding Station can also be used by other customers and stakeholders.
- The breastfeeding station is well-equipped with a refrigerator where nursing employees can store the collected milk. It has also a lavatory with soap, table, comfortable chairs, water dispenser and a well ventilated space.
- Minimum health and safety protocols shall be strictly observed in the area.
- The SHS is primarily responsible in the monitoring of activities, and use of equipment and supplies.
