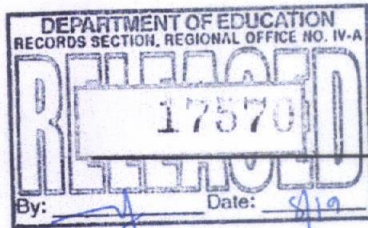

Regional Memorandum

**PARENT'S AFFIDAVIT/DECLARATION AS SUBSTITUTE FOR
BIRTH CERTIFICATE**

To: **Schools Division Superintendents**

1. Pursuant to DepEd Order No. 03, s. 2018, it is the policy of the Department of Education to uphold the right of learners to enroll in public schools upon presentation of minimum documentary requirements and to be provided with accessible, relevant, quality, and liberating education.
2. The same DepEd Order provides for the minimum documentary requirements that a learner must present during the enrollment in public schools. However, in the absence of a PSA Birth Certificate, the parent or guardian must submit a Birth Certificate (late registration) from the local civil registrar or a *barangay* certification containing the basic information of the child such as the name of the child (first name, middle name, last name); the name of parents; date of birth; and sex.
3. This Office recognizes the fact that some officials in the *barangay* are indecisive in giving *barangay* certification either because they have difficulty in gathering or establishing the true identity of the parent/s or guardian/s seeking *barangay* certification, or they are not sure if the concerned parent/s or guardian/s is indeed the legitimate parent/s or guardian/s of the learners.
4. Thus, in lieu of the *barangay* certification, the parent/s or guardian/s concerned may utilize the Parent's Affidavit/Declaration Form (attached herein as an *enclosure*) in the non-availability of the birth certificate.
5. Provided that the parent/s or guardian/s concerned shall present or submit the original birth certificate within three (3) months from the execution of the Parent's Affidavit/Declaration Form.




