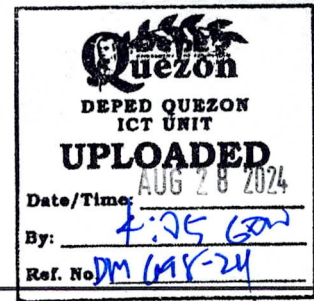

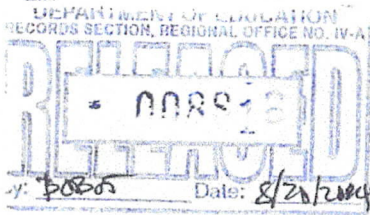

1. Relative to the conduct of the 9<sup>th</sup> DepEd CALABARZON Gawad Patnugot Stage 2 Onsite Validation, this Office, through the HRDD, in collaboration with the Regional PRAISE Committee, releases the updated schedule of the 9<sup>th</sup> DepEd CALABARZON Gawad Patnugot due to the cancellation of classes caused by the high levels of vog, or volcanic smog, from Taal Volcano. Please see attached updated schedule and the list of regional validators.
2. The Regional PRAISE Committee reiterates to all regional validators and qualifiers to observe and be guided by **RA 6713** otherwise known as the **Code of Conduct and Ethical Standards for Public Officials and Employees** specifically Section 7d, "*Public officials and employees shall not solicit or accept, directly or indirectly, any gift, gratuity, favor, entertainment, loan or anything of monetary value from any person in the course of their official duties or in connection with any operation being regulated by, or any transaction which may be affected by the functions of their office.*"
3. As agreed during the August 8, 2024, virtual meeting with the SDO Rewards and Recognition focal persons, only the regional validator sub-teams who are within or near the area of the SDOs will pay courtesy visits to the SDSs. Those who are far from the office shall go directly to the school or sub-office to maximize time.
4. To keep updated on the conduct of the onsite validation, SDO R&R focal persons, alternates and other concerned may access this link for the needed information such as schedule of validation, regional validators, link for the feedback, folder for photos and videos of the documenters.

Expenses incurred by the schools and SDOs relative to the Stage 2 onsite validation shall be charged against their local funds, while the travel expenses, board and lodging, and other related miscellaneous expenses of the regional validators shall be charged against local funds subject to the usual accounting and auditing rules and regulations.
