The Department of Education (DepEd), in partnership with the Department of Information and Communications Technology (DICT) and the Commission on Elections (COMELEC), strives to complete the processing of Philippine National Public Key Infrastructure (PNPKI) Digital Certificates for all its personnel who are willing to serve in the 2022 National and Local Elections (NLE).

With this, Schools Division Office (SDO) PNPKI Focal Persons and Members **must expedite** the validation and certification processes at their level, and submit the same to their Regional PNPKI team **not later than 29 September 2021**.

PNPKI Regional Focal Persons must also expedite the processing of received/on hand certified applications from SDOs and send those to the DICT Cluster Offices through proper channels immediately. Also, succeeding submissions from SDOs must be forwarded to the DICT not later than 30 September 2021 at 11:59 p.m.

In addition, all DepEd Regional PNPKI teams **must submit every other day** the number of submitted applications to the PNPKI cluster offices and to icts.usd@deped.gov.ph. This is for the monitoring of progress in their respective areas and cross-checking with the DICT.

DepEd personnel who will not serve in the 2022 NLE are **still encouraged** to submit their applications through the DepEd Learning Management System (DLMS) **on or before 31 October 2021 at 11:59 p.m.** The benefit of the current arrangement between DepEd and DICT is that the following requirements have been waived: (1) submission of identification cards and legal documents such as Marriage or Birth Certificates; and (2) setting appointments for virtual face-to-face validation.

Kindly note that the **Certificate of Completion** generated in the DLMS **is NOT the PNPKI Digital Certificate itself**. Rather, it is an indication of successful submission of the application and that all information, signatures, and pictures are in order. For security purposes, the PNPKI will send a message directly to the email address in the application form, which will include instructions on how to activate the PNPKI Digital Certificate.
