

1. Relative to the Plan Adjustment from the Mid-year Performance Review conducted last July 21-23, 2021 by the SGOD-School Health Section, this Office announces the use of locally developed **Learners' Health Survey Form (LHSF)** through **PROJECT HEAL** (Project Health Examination and Assessment of Learners) to address issues and concerns relative to KRA no. 1 as to the conduct of health appraisal activity among learners.
2. The LHSF in Filipino shall be provided to learners from **Kindergarten to Grade 12** to continuously assess their health condition despite the New Normal setting.
3. Printing and other supplies relative to the reproduction and distribution of the LHSFs may be charge to school MOOE or source through partnership with stakeholders in the spirit of **Bayanihan sa Kalusugan: OK sa DepEd sa Paaralan at Tahanan**.
4. Printed LHSFs shall be given to learners in the distribution of modules, and shall be retrieved by the advisers for consolidation of the district nurses.
5. Strict adherence to safety and health protocols being implemented by the IATF and the Local Government Units must be observed. The school personnel shall also ensure that protocols are observed at all times during the activity.
6. Immediate dissemination of and strict compliance to this Memorandum is highly desired.
