

1. In line with the Department of Education's commitment to strengthen results-based monitoring and evaluation systems for improved basic education outcomes, this Schools Division Office will conduct the **Division Orientation on the Basic Education Monitoring and Evaluation Framework (BEMEF)** on **September 24–25, 2025** via **Zoom**.
2. This activity is pursuant to **DepEd Order No. 29, s. 2022** (Adoption of the Basic Education Monitoring and Evaluation Framework), which institutionalizes the BEMEF as the primary guide for planning, monitoring, and evaluating basic education programs, projects, and activities (PPAs) at all governance levels.
3. The orientation aims to familiarize participants with the principles, structure, and processes of the BEMEF; strengthen their capacity in aligning PPAs with the BEMEF results chain; and ensure the effective utilization of monitoring and evaluation tools in support of evidence-based decision-making.
4. The participants are the **Public Schools District Supervisors (PSDSs)** and **School Heads of public elementary and secondary schools**, who are advised to ensure stable internet connectivity during the sessions.
