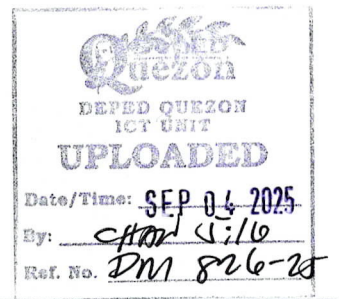

Relative to Regional Memorandum No. 595 s. 2025 titled "*Regional Orientation for School Heads and Capacity Building of Division Trainers on the Academic Recovery and Accessible Learning (ARAL) Program*", this Office announces the conduct of the **Division Capacity Building of District Trainers on the Academic Recovery and Accessible Learning (ARAL) Program** on **September 10-11, 2025** within Lucena City. Specific venue to be announced through separate advisory.
2. The activity aims to capacitate the core of district trainers of ARAL Tutors on learner-centered pedagogy, psychological first-aid, handling learners with diverse needs, and the effective utilization of ARAL learning resources, educational technologies and other supplementary materials.
3. There shall be **five (5) participants** from every district to attend the training representing **Key Stages 1, 2 and 3** with the following qualifications to be considered:
  - must be a Supervisor, School Principal, Head Teacher and/or Master Teacher.
  - with effective facilitation skills and strong knowledge in integrating Social Emotional Learning (SEL) in class instructions.
  - with expertise in designing strategies in teaching Filipino and English subjects to learners with varied challenges with literacy and comprehension and developing activities for remediation sessions
