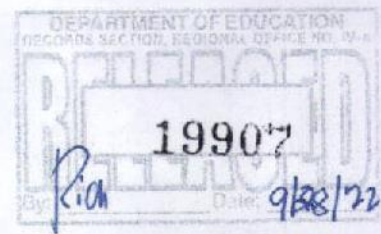

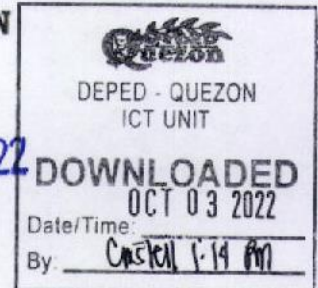



6. A technical dry run will be conducted in the morning of the scheduled livestreaming. All personnel involved in the program's production team are required to attend both the technical dry run and the actual livestream.
7. The Regional Office (RO) will invite guests as resource persons from SDOs and schools to share their expertise, best practices and experiences on the topic.
8. Segments included in Season 3 episodes are:
- WELLness** – Physical health, mental health, disaster preparedness, first aid, etc.
  - "Legal Matters"** – Legal Officers discusses legal issues/ bases and answers frequently asked questions (FAQs)
  - TAL'ento (Talent na may Kwento)** – Weekly intermission number either musical, dance, arts, etc. featuring students, teachers, non-teaching personnel, parents per episode.
  - ABT (Audience Bubble Talk...Ano Ba Talaga?)** – Recorded videos of students asking questions about the topic of the week.
9. The program will be livestreamed every **Wednesday at 2:00 p.m.** on these official Facebook (FB) pages of DepEd CALABARZON RO; DepEd R-4A
