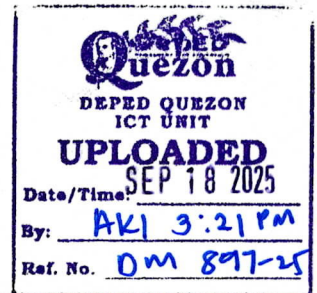

**TRAINING FOR DIVISION SCHOOL HEALTH PERSONNEL AND DRRM  
CORE RESPONDERS TEAM**

1. **Republic Act No. 10121, s. 2010** titled "The Philippine Disaster Risk Reduction and Management Act of 2010" mandates preparedness, capacity-building, and training of disaster risk reduction and management (DRRM) stakeholders at all levels. **DepEd Order 49, s. 2014** titled "Guidelines on the Functions and Assignment of School Health and Nutrition Personnel in DepEd" provides that school health staff have roles in health emergency preparedness, preventive health, and school safety. This Office announces the conduct of the Division Training for School Health Personnel and DRRM Core Responders Team on September 20-21 and 28, 2025 at Ouan's The Farm Resort, Lucena City.
2. This training aims to strengthen the capacity of **School Health Personnel** and **DRRM Core Responders DRRM District Coordinators** at the division level in order to equip them with updated knowledge on disaster risk reduction and management, especially hazards specific in the locality; strengthen their skills in emergency procedures, first aid, health risk assessment in the schools;

- clarify roles and coordination among health personnel, DRRM team, school heads, DRRM Section units during emergencies; ensure that schools are safe, resilient, and able to protect the welfare of learners and personnel in case of disasters or health emergencies.
3. The expected participants are **School Nurses, School Heads and other School Personnel** from public schools who have been designated or trained to serve as part of the DRRM Core Response Team. These are individuals who are capable of acting as first responders in emergency situations and are responsible for coordinating DRRM activities in their respective schools.
  4. All DepEd personnel who will render services during weekends shall be given service credits and Compensatory Overtime Credits (COC) for the teaching related and non-teaching personnel based on the actual services rendered during this training.
  5. Please refer to Enclosure No. 1 for the list of participants, No. 2 for the list of Technical Working Group.
  6. Meals, venue and accommodations of all the participants during the conduct of the activity shall be charged against the Disaster Preparedness and Response Program (DPRP) Continuing Fund while the transportation expenses shall be charged against school MOOE or other local funds of the school, subject to the usual accounting and auditing rules and regulations.
  7. Immediate dissemination of this Memorandum is desired.
