**REQUEST FOR SUBMISSION OF DATA ON SCHOOLS REQUIRING ACCESSIBLE  
THROUGH HANGING BRIDGES OR BY CROSSING BODIES OF WATER**

1. In reference to Regional Memorandum No. 652, s. 2025 titled "2025 Climate Change In reference to **DepEd Memorandum DM-OUHROD-2025-2319** dated 29 August 2025, the Department of Education is currently gathering data on schools located in areas where access to education facilities involves traversing hanging bridges or crossing bodies of water.
2. This data-gathering initiative seeks to identify schools situated in **Geographically Isolated, Disadvantaged, and Conflict-Affected Areas (GIDCAs)** where learners and personnel experience challenges in physically accessing school. The collected information will support ongoing efforts to ensure safe and reliable school access and will aid in the implementation of the **Payapa at Masaganang PamayanAn (PAMANA) Program**, a peace and development initiative of the **Office of the Presidential Adviser on Peace, Reconciliation, and Unity (OPAPRU)**.

- b. Include the following information for each identified school:
- **Schools where learners, teachers, and non-teaching personnel regularly cross**
    - Existing hanging bridges in need of repair or replacement
    - Rivers or other bodies of water without an existing bridge, where a hanging bridge may be constructed to facilitate safer and faster travel
  - **Details for each identified school**
    - Complete school name and school ID
    - Exact location (barangay, municipality/city, province)
    - Estimated number of learners affected
    - Estimated number of DepEd personnel affected
    - description of current route taken, including estimated distance and travel time
    - Current condition of hanging bridge (if existing)
    - Nature of body of water being crossed
    - Reports of accidents, incidents, or near misses that occurred during travel to or from school (date, brief description, and persons affected)
    - Any recorded hazards or safety concerns
4. The information collected will be used to support the identification and prioritization of infrastructure projects under the **PAMANA Program**.
5. Immediate and timely submission of the required data is highly encouraged. Full cooperation from all concerned is expected.
