1. In support to the programs and projects of the **Boy Scouts of the Philippines (BSP) Quezon Council**, this Office informs the field of the designation of District School Head In-Charge of Boy Scouting.
2. The selection of appointee shall be facilitated by the District Scout Commissioner (Public Schools District Supervisor). The appointee will serve for a term of one year which can be renewed upon the discretion of the appointing authority. However, the appointee can be replaced even before the expiration of term based on the performance of duties.
3. The District School Head In-Charge shall maintain scouting at high level with proper coordination with the District Troop Leaders, District Kawan Leaders and Institutional Scouting Coordinators and other scouting benefactors and shall closely monitor the performance of each school.

5. Immediate dissemination of and strict compliance to this Memorandum is highly desired.


