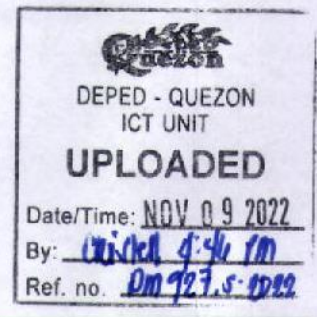

1. Pursuant to **DepEd Order No. 003, s. 2021**, otherwise known as the **Creation of Child Protection Unit and the Child Rights in Education Desk in the Department of Education**, the CPU establishes the "Tatag CPC" Program which aims to promote the functionality, establishment and strengthening of Child Protection Committees (CPCs). Part of this is the conduct of training workshops on establishing functional CPCs.
