- 1. In accordance with DepEd Order No. 35, s. 2017, titled "Revised Guidelines on the Implementation of the Basic Educational Facilities Fund," regular monitoring and joint inspections are required to ensure the quality of our school infrastructure works.
- 2. School heads/Principals should raise any concerns regarding ongoing projects or contractors with the DepEd Engineer/Division Engineer during the monitoring/joint inspections, especially if the projects pose a hazard/threat to students, teachers, or non-teaching personnel. For urgent concerns, school heads/principals may contact the Education Facilities Section via the email provided in this memorandum.
- 3. School heads/Principals are advised to designate a representative in their absence during the monitoring/joint inspections.
- 4. Transportation costs and other expenses incurred by the monitoring team will be charged to their respective MOOE and are subject to existing budgeting, accounting, and auditing rules and regulations.
- 5. Schools are highly discouraged from preparing luxurious meals.
- 6. The list of recipient schools and their regular schedule of monitoring/joint inspection are detailed in Enclosure A.


