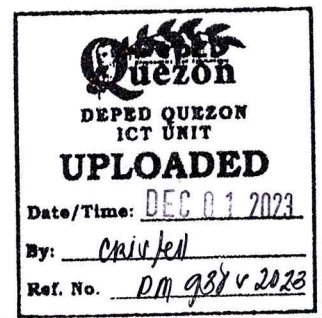

**ROLL-OUT TRAINING ON THE ENHANCED BUDGET
MONITORING SYSTEM (eBMS)**

Secondary School Heads

1. As an offshoot to the Training on the Enhance Budget Monitoring System (eBMS) which was held on November 21-24, 2023 at Loreland Farm Resort, Antipolo City, the Finance Division will conduct the Roll-out Training on Enhanced Budget Monitoring System (eBMS) which aims to train all secondary schools implementing units of this Region on December 4-5; 6-7; 11-12 and 13-14, 2023 in four (4) batches, venue within Batangas, Laguna, Cavite and Quezon.
2. The objectives of this activity are as follows:
 - 2.1 To capacitate the finance personnel in secondary schools implementing units on the enhanced Budget Monitoring System of the DepEd Central Office;
 - 2.2 To synchronize the systems and procedures on the use of eBMS for uniformity purposes of reportorial submission to DepEd CO, DBM and oversight agencies; and
 - 2.3 To integrate DepEd internal systems and processes, upgrade other finance personnel capacity and ensure efficiency in the processing of finance-related transaction.
3. Participants in this activity are the Senior Bookkeepers of the Secondary Schools Implementing Units and other Finance personnel who were included as attendees during the Training on eBMS.
4. A registration fee of P4,000.00 shall be charged for each participant chargeable against their respective local funds subject to the usual budgeting, accounting and auditing rules and regulations.
