

2024 NATIONAL OBSERVANCE OF THE FILIPINO VALUES MONTH

- 1. In compliance to Presidential Proclamation No. 479 titled "Declaring the Month of November Every Year as Filipino Values Month" and Regional Memorandum No. 790 s. 2024, "2024 National Observance of the Filipino Values Month", this Office through the Curriculum Implementation Division (CID) joins the nation in the celebration of the 2024 National Observance of the Filipino Values Month with the theme, "Pagsusulong ng Bagong Pilipinas: Ang Kabataan Bilang Pundasyon ng Pagbabago".
- 2. During the month-long observance, all schools, are encourage to integrate the Filipino values in the teaching-learning activities, not only in Edukasyon sa Pagpapakatao (EsP), Good Manners and Right Conduct (GMRC) and Values Education (VE) but also in all the different learning areas. Likewise, such values can also be incorporated in the activities of the celebrations of the month.
- All schools in collaboration with other stakeholders may create campaign and advocacy
 materials anchored on the theme to increase awareness among learners and community.
- 4. Activities relative to the observance of the Filipino Values Month (FVM) shall be held in accordance with the DepEd Order No. 9 s. 2005, titled "Instituting Measure to Increase Engage Time-on Task and Ensuring Compliance Therewith" and DO No. 009 s. 2024.







