

**VIRTUAL ORIENTATION OF DIVISION SCREENING AND ACCREDITATION

1.  - d. common accreditation issues and resolutions from previous years,
 - e. timeline for submission and verification of documents.
3. To strengthen the efficiency and integrity of the accreditation process, all DSAC members are requested to review the *Palarong Pambansa* Guidelines, particularly the latest memorandum or issuances concerning eligibility, documentary requirements, and deadlines.


