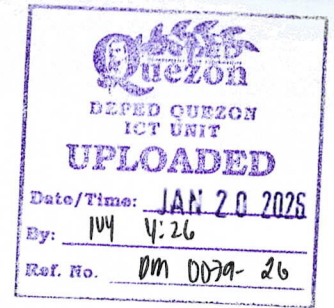

1. In compliance with **DM-OUOPS-2025** titled **Learner Government (LG) Elections for School Year (SY) 2026-2027**, this Office, through the School Governance and Operations Division – Learner Formation Section (SGOD-LFS), announces the conduct of the Learner Government school level elections on **January 26, 2026 to February 11, 2026**.
2. This activity shall amplify the voices of learners for representation and decision-making. Specifically, this activity aims to provide support to all learners to instill effective leadership which shall contribute to their holistic development.
3. All schools shall adhere to the guidelines and templates that will be discussed during the **Online Orientation on the Learner Government Election and Appointment Code (LGEAC)** on January 21, 2026. The materials can be accessed and downloaded at **<https://tinyurl.com/LGElectMaterials26>**.
4. The school's Learner Government Commission on Election and Appointment (LG COMEA) shall submit its election results on or before **February 12, 2026** through the database system that will be introduced during the online orientation on election guidelines.
5. All District School Heads In-Charge of Learner Formation shall monitor the conduct of school level elections. They shall select one elementary and one secondary school regardless of size or classification. The accomplished monitoring tool (see Enclosure)

 7. All expenses incurred in the conduct and monitoring of school level elections shall be charged against school MOOE/local funds subject to the usual accounting and auditing rules and procedures.
