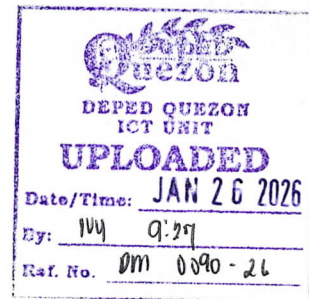

In compliance with **DM-OUOPS-2025-10-07908** titled **Learner Government (LG) Elections for School Year (SY) 2026-2027**, this Office, through the School Governance and Operations Division – Learner Formation Section (SGOD-LFS), announces the conduct of the Learner Government district level elections on **February 12-13, 2026**.
2. This activity shall amplify the voices of learners for representation and decision-making. Specifically, this activity aims to provide support to all learners to instill effective leadership which shall contribute to their holistic development.

4. The district's Learner Government Commission on Election and Appointment (LG COMEA) shall submit its election results through the approved registry of elected officers during the division level elections on **February 14, 2026** duly signed as per election guidelines.

Conduct of all activities related to the Learner Government Program (LGP) shall follow the provisions in **DepEd Order No. 09, s. 2005 – Instituting Measures to Increase Engaged Time-on-task and Ensuring Compliance Therewith; DepEd Order No. 03, s. 2023 – An Order Allowing the Conduct of In-person Activities in Schools;**
