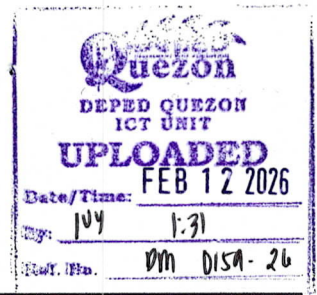

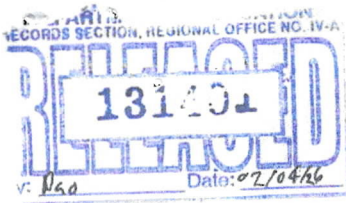

6. A Technical Dry Run/ Full Rehearsal is scheduled a day before the live streaming. All personnel involved in the program are expected to attend both the technical dry run and the actual live stream. Food will be provided to the production team during Actual Live Streaming day.
7. The production team will invite guest/s resource persons from the Regional Office, Schools Division Offices, and schools to share their expertise, best practices and experiences on specified topic/themes.
8. Season 7 Segments:
- a. **WELLness** – Physical health, mental health, disaster preparedness, partnership, etc.
 - b. **“Know Your Rights”** – Learner Rights and Protection (LRP) to discuss pressing issues/concerns and answer Frequently Asked Questions (FAQs) on LRP.
 - c. **TAL’ento (Talent na may Kwento)** – Intermission number either musical, dance, arts, etc. featuring students, teachers, non-teaching personnel, parents per episode.

- d. **Taga-DepEd Ako** – Inspiring Stories of DepEd personnel, learners and stakeholders.
9. The production will be broadcasted on the official Facebook pages of DepEd CALABARZON Regional Office. These are DepEd R-4A Calabarzon (<https://www.facebook.com/deped.calabarzon>) and DepEd Tayo Calabarzon (<https://www.facebook.com/DepEdTayoCalabarzon>) on the specified dates mentioned above.
