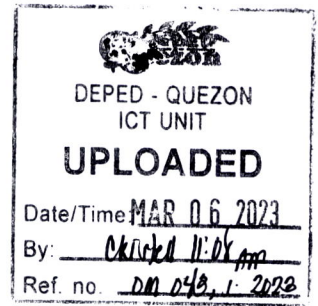

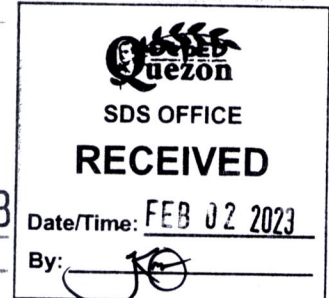
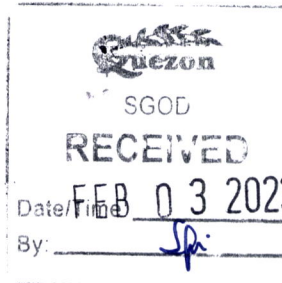

Dear Sir Alicaya:

Universal Health Care (UHC) mandates that every Filipino shall be granted immediate eligibility and access to preventive, promotive, curative, rehabilitative and palliative care. The UHC Law seeks to re-integrate the Philippines' highly devolved governance system into province-wide health systems to ensure a more efficient use of resources and delivery of comprehensive care.

It is in this light that PhilHealth expanded its primary care benefit into the PhilHealth Konsulta, with expanded rates and service inclusions, accessible to all membership types.

PhilHealth Konsultasyong Sulit Tama (Konsulta) is a comprehensive outpatient benefits as mandated by the Universal Health Care Law which aims to:

- ✓ Protect the health of every Filipinos against chronic illnesses
- ✓ Avoid complications through early detection
- ✓ To provide affordable drugs and medicines

Under the PhilHealth Konsulta, all Filipinos shall be registered with an accredited PhilHealth Konsulta Provider of their choice and be eligible to avail of the following:

- ✓ Consultation
- ✓ Health Risk Screening and Assessment
- ✓ Selected Laboratory and Diagnostic Test
- ✓ Selected Drugs and medicines

However, to avail of the services, members need to be registered to their PhilHealth Konsulta provider of choice. Thus, we are seeking your support to register all your personnel to their preferred PhilHealth Konsulta facility so that they can enjoy the preventive services under the program.
