

# CONDUCT OF QUALITY ASSURANCE, MONITORING AND EVALUATION (QAME) OF ALL DIVISION PROGRAMS, PROJECTS AND ACTIVITIES (PPAs)

In line with the implementation of **DepEd Order No. 029**, **s. 2022** (Adoption of the Basic Education Monitoring and Evaluation Framework), this Office, through the School Governance and Operations Division – School Management Monitoring and Evaluation (SGOD-SMME), shall conduct quality assurance, monitoring, and evaluation (QAME) of all types of Programs, Projects, and Activities (PPAs) organized and implemented in the Division.

The **PPAs to be subjected to QAME** shall include but not be limited to trainings, seminars, workshops, writeshops, conferences, plenum, meetings, rewards and recognition activities, sports activities, recruitment, selection and placement activities, focus group discussions, technical assistance activities, webinar, coaching/mentoring, and orientation.

The QAME request for all types of PPAs shall take effect starting the **second quarter** of Fiscal Year 2024.

Please be informed that the scope of QAME shall only cover the **Reaction Level of the Kirkpatrick Four-Level Training Evaluation Model** which measures the degree to which participants react favorably to the learning experience in the PPA provided.

Relative to this, all program owners shall process their QAME request through the SGOD-SMME at **least seven working days** before the conduct of the PPAs using the provided links below:






The summarized results of QAME for all PPAs shall be reported quarterly during the **Division Program Implementation Review and Plan Adjustment (PIRPA)** to further discuss ways to address issues and concerns regarding the implementation of PPAs.
