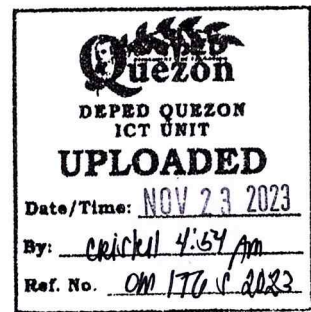

Relative to the release of **DepEd Order No. 30, s. 2019** titled The Department of Education Manual of Style (DMOS) prescribing the latest language style, format, and usage, of gender-fair or non-sexist language and highlighting the significance of institutionalizing a common format of official communications, presentations, learning resources, advocacy materials, citations, and all other collaterals, the Division GAD Focal Point System (DGFPS), in collaboration with the SGOD-SMME Section, will conduct a **Seminar-Workshop on the Use of Gender-Fair Language cum DepEd Service Marks and Visual Identity Manual on November 28 – 29, 2023**. The venue of the said activity will be announced through a separate Memorandum.

Specifically, the said activity has the following objectives:

- Orient the participants on the DepEd Service Marks and Visual Identity Manual (DMOS) using gender-fair language.
- Integrate the gender-fair language into the standards of DMOS in language styling, writing, and formatting of DepEd issuances (Dis) and other official documents.
- Provide TA on preparing official issuances and correspondence using the gender-fair language.


