- With reference to Regional Memorandum No. 320, s. 2024, this Office through the Policy, Planning and Research Division (PPRD) announces that the onsite monitoring of the research studies under the ⁹ Cycle BERF grants is then rescheduled on October 7-31, 2024.
- 2. This monitoring activity shall focus on the following:
 - a. Implementation status and activities based on the approved work plant
