For the information of all concerned, attached is an Unnumbered DepEd Memorandum entitled "Conduct of Graduation Rites During the Covid-19 Pandemic", which is self explanatory from the Offices of Usec. Mateo and Usec. Escobedo.

In response to the World Health Organization (WHO) declaring COVID-19 as a pandemic, the Department of Education (DepEd) issued DepEd Order No. 02, s. 2020, entitled "The New Implementing Guidelines on the K to 12 Basic Education Program End-of-Year Exam, stating each school shall have the discretion to select the date of graduation with taking into consideration the applicable guidelines by the Department of Health (DOH). Moreover, should the public health situation prevent the holding of a school's exam, the schools, in consultation with the Parents-Teachers Association (PTA) leadership, may choose to postpone or change the date of the exam.

In light of the demand and as a contribution to government's efforts in COVID-19, the Department maintains that graduation activities that require face-to-face interactions shall be postponed until further notice. Community Learning Centers are highly encouraged to conduct alternative non face-to-face activities to celebrate the end of the year. Furthermore, activities that may require face-to-face interactions should and IATF guidelines may be heeded only if the need arises.

Furthermore, activities that may require face-to-face interaction and allowed through DepEd and IATF guidelines may be conducted **only if** the necessary health and safety

precautions are **strictly** complied with, subject to the guidelines set for the community quarantine classification of the locality.

For schools that have yet to conduct the end of school year rites, school heads must submit to the Schools Division Superintendent (SDS) for approval their proposed process for e-graduation rites (including logistics) before conducting the event.

All DepEd officials are reminded that the safety of our learners and personnel during this period of national emergency takes precedence. Strict observance of the health and safety standards and protocols are expected from all to minimize the risk of exposure and mitigate the spread of COVID-19.
