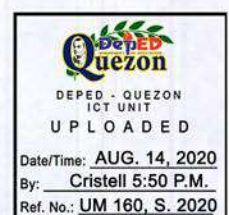
All concerned school heads, property custodians, elementary nurses and dentists are hereby advised to be on their respective schools during the said delivery schedule to receive and inspect the supplies.


